



2011 Evidence and Impact Research Grants

Essential information for applicants!

1. ESPA is an international research programme, funded as a global public good and designed to produce world-class research and evidence to promote the sustainable management and use of ecosystem services to promote poverty alleviation. Your proposal must demonstrate how you will contribute to this process.
2. The 2011 Evidence and Impact Research Grant (EIRG) projects will be expected to generate research and evidence to contribute to global policy and evidence processes during 2012 (and beyond). These must include one or more of the processes of Rio 2012, the IPCC 5th Assessment Report and the Convention on Biological Diversity.
3. **You do not need to include researchers from the United Kingdom in this application!** The ESPA programme will particularly welcome applications that are led by developing country researchers or developing country research institutions.
4. **You must include a developing country researcher in your proposal.** A developing country researcher will have the nationality of a low or middle income country. There is no restriction on where they are working (i.e. they may be working in an institution that is located in a developed country).
5. At least 33 % of the total work effort (number of days of work) must be assigned to one or more developing country researchers.
6. The ESPA programme welcomes applications from researchers from any country who can demonstrate their ability to generate world-class research contributing to ESPA's research agenda as described in the [ESPA Research Framework](#). You should read this document before designing your research and completing this form.
7. All ESPA research projects are required to describe **how** their research could have the potential to benefit the world's poor, **who** would use the research (both directly and indirectly) and **what** the project will do in order to make this possible. You should read the [ESPA Impact Framework](#) before designing your research and completing this application.
8. Further essential information relevant to your application is contained in the ESPA Directorate Evidence and Impact Research Grants 2011 (EIRG) (<https://in-tendhost.co.uk/edinburghuni/>).
9. Highly relevant information about ESPA's research themes and evidence challenges is available on the ESPA website and in Annex 1 of the EIRG document, which should be read before completing your application.
10. CVs must be submitted using the EIRG CV Template and may not exceed two pages in length. (The format must be: Arial font with a minimum size of 11pt).
11. Your application needs to include electronic copies of this form, the budget spreadsheet and a 2-page CV for every member of staff included in this proposal. **Any incomplete application will be rejected before technical review.**
12. Word and character limits indicated in this form will be strictly enforced and checked automatically on submission. **Any proposal that exceeds the word or character limits will be rejected before technical review.**
